

NOTICE OF SPECIAL ELECTION
TO BE HELD ON MAY 18, 2021

NORTH MASSAPEQUA FIRE DISTRICT
IN THE TOWN OF OYSTER BAY,
NASSAU COUNTY, NEW YORK

NOTICE IS HEREBY GIVEN that pursuant to the resolution duly adopted by the Board of Fire Commissioners of the North Massapequa Fire District, in the Town of Oyster Bay, Nassau County, New York, a Special Election of the qualified voters of said Fire District, will be held at Fire District Headquarters, 1000 North Broadway, North Massapequa, New York, on May 18, 2021, at 6:00 P.M. (Prevailing Time) and the polls shall remain open until 9:00 P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes upon the following Proposition:

PROPOSITION

SHALL the bond resolution of North Massapequa Fire District, in the Town of Oyster Bay, New York, entitled: “BOND RESOLUTION OF THE NORTH MASSAPEQUA FIRE DISTRICT, IN THE TOWN OF OYSTER BAY, NASSAU COUNTY, NEW YORK, ADOPTED APRIL 5, 2021, AUTHORIZING THE CONSTRUCTION OF AN ADDITION TO AND THE RECONSTRUCTION OF FIRE DISTRICT HEADQUARTERS LOCATED AT 1000 NORTH BROADWAY, NORTH MASSAPEQUA, NEW YORK, STATING THAT THE ESTIMATED MAXIMUM COST THEREOF, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND THE FINANCING THEREOF, IS \$5,350,000; APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE, INCLUDING THE EXPENDITURE OF APPROXIMATELY \$850,000 FROM INSURANCE PROCEEDS; AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$4,500,000 BONDS OF THE FIRE DISTRICT TO FINANCE THE BALANCE OF SAID APPROPRIATION; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID PROJECT IS TWENTY-FIVE (25) YEARS; AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE,” be approved?

All residents of the Fire District who were duly registered to vote with the Nassau County Board of Elections on or before April 26, 2021, shall be eligible to vote at said Special Election.
