WHEREAS the NORTH MASSAPEQUA FIRE DISTRICT finds it necessary to purchase One Spartan Pumper and One Ferrara Ladder Truck Fire Apparatus through the use of an installment purchase contract due to the firefighting and emergency service needs of the Fire Department and Fire District and the funds available to purchase such equipment; and

WHEREAS, the BOARD OF FIRE COMMISSIONERS has determined that such purchase will enable the Fire District to better serve the firefighting and emergency service needs of the residents and taxpayers of the NORTH MASSAPEQUA FIRE DISTRICT; and

WHEREAS, the BOARD OF FIRE COMMISSIONERS of the NORTH MASSAPEQUA FIRE DISTRICT has obtained a quote for the purchase of such equipment from Spartan and Ferrara manufacturers based upon piggyback bidding permitted under General Municipal Law §103 through the Houston Galveston Area Council purchasing cooperative and for the financing of an installment purchase contract from 911 Leasing.com after conducting an evaluation of financing alternatives, with the cost of said purchase being as follows:

The cost of the One Spartan Pumper and One Ferrara Ladder Truck Fire Apparatus prior to financing being \$2,540,662.00 with an offer from 911 Leasing.com to finance \$1,340,662.00 of the purchase price through an installment purchase contract based upon a plan to pay \$1,200,000.00 as a down payment from reserves and to finance the remaining cost of the two trucks in the amount of \$1,340,662.00 with following pricing:

Ten (10) Year Term: \$169,168.20 annual payment (3.99% interest rate).

WHEREAS, the BOARD OF FIRE COMMISSIONERS of the NORTH MASSAPEQUA FIRE DISTRICT has employed Munistat to evaluate these financing terms in accordance regulations adopted under Section 109-b of the General Municipal Law, and

WHEREAS the BOARD OF FIRE COMMISSIONERS of the NORTH MASSAPEQUA FIRE DISTRICT will adopt a separate resolution relative to financing alternatives.

BE IT RESOLVED, that the NORTH MASSAPEQUA FIRE DISTRICT shall purchase the above-described One Spartan Pumper and One Ferrara Ladder Truck Fire Apparatus by use of an installment purchase contract based upon the lump sum purchase price of \$2,540,662.00 submitted by Spartan and Ferrara through the Houston Galveston Area Council purchasing cooperative and shall utilize an installment purchase contract over a Ten (10) Year Term based upon the quote provided by 911 Leasing.com which takes into account a plan to finance a part of the purchase price totaling \$1,340,662.00 by the installment purchase contract or such other lender offering more favorable terms subject to applicable financial market forces since such quotes may be subject to renegotiation given the time required to hold this mandatory referendum; and

BE IT FURTHER RESOLVED that the BOARD OF FIRE COMMISSIONERS of the NORTH MASSAPEQUA FIRE DISTRICT reserves the right to purchase all or a portion of the equipment directly under the purchasing cooperative lump sum price without the use of installment purchase financing, and that to the extent that it does so, the equipment amount and cost may be reduced for this installment purchase contract, and the corresponding annual installment payment will be reduced; and

BE IT FURTHER RESOLVED that the NORTH MASSAPEQUA FIRE DISTRICT shall conduct a mandatory referendum on February 28, 2023, between the hours of 6:00 p.m. and 9:00 p.m. in order to determine whether the Board of Fire Commissioners may purchase such One Spartan Pumper and One Ferrara Ladder Truck Fire Apparatus by use of an installment purchase contract; and

BE IT FURTHER RESOLVED, that such mandatory referendum of the registered voters of the NORTH MASSAPEQUA FIRE DISTRICT, in the Town of Oyster Bay, County of Nassau, State of New York, shall be held at the North Massapequa Fire District Building located at 960 Hicksville Road, Seaford, New York, commencing at 6:00 p.m., prevailing time, on February 28, 2023, and the polls shall remain open until 9:00 p.m., prevailing time, that evening or as much longer as may be necessary to enable the voters then present to cast their votes; and

BE IT FURTHER RESOLVED that the Proposition to be submitted to the registered voters shall be by voting machine or by paper ballot and the Fire District Secretary is hereby authorized and directed to have the necessary machines and ballot strips and/ or paper ballots prepared for said use; and

BE IT FURTHER RESOLVED that the Fire District Secretary is hereby authorized and directed to give notice of said mandatory referendum; and

BE IT FURTHER RESOLVED that the Chairman, Election Inspectors, and Ballot Clerks for said mandatory referendum (hereinafter referred to as Election Board) shall be the resident electors of the fire district named to serve in those capacities in the separate resolution adopted by the Board on this same date, and that they shall receive as compensation that amount specified in said resolution described above; and

BE IT FURTHER RESOLVED that the Election Board shall meet at the North Massapequa Fire District Building, located at 960 Hicksville Road, Seaford, New York on February 28, 2023, between the hours of 3:00 p.m. and 6:00 p.m., to commence preparation of the rolls of registered voters for said mandatory referendum; and

BE IT FURTHER RESOLVED, that in preparing such register, the Inspectors of Election shall comply with the following procedure:

- (a) They shall adopt, use or copy from, the registration list certified and supplied by the County Board of Elections the names appearing thereon of all persons residing in the Fire District and qualified to vote in such forthcoming Fire District election.
- (b) The register for the Fire District shall include as a minimum the space for the name of the voter, his address within the Fire District and a space for his signature to be signed by the voter on election day; and
- (c) The Fire District Secretary shall furnish the Inspectors of Election, at Fire District expense, with all necessary registration books, papers, equipment, and supplies.

BE IT FURTHER RESOLVED that the Proposition to be submitted to the voters of the NORTH MASSAPEQUA FIRE DISTRICT shall be in the following form:

"SHALL THE RESOLUTION OF THE NORTH MASSAPEQUA FIRE DISTRICT IN THE TOWN OF OYSTER BAY, COUNTY OF NASSAU, STATE OF NEW YORK, ADOPTED BY THE BOARD OF FIRE COMMISSIONERS OF THE NORTH MASSAPEQUA FIRE DISTRICT ON JANUARY 9, 2023 AUTHORIZING AND EMPOWERING THE PURCHASE OF ONE SPARTAN PUMPER AND ONE FERRARA LADDER TRUCK FIRE APPARATUS BASED UPON AN INSTALLMENT PURCHASE CONTRACT CALLING FOR THE PAYMENT OF THE SUM \$1,200,000.00 FROM THE FIREMATIC EQUIPMENT CAPITAL RESERVE FUND AND FINANCING THE BALANCE SUM OF \$1,340,662.00 BY FINANCING SAID AMOUNT OVER A TEN (10) YEAR TERM OF LEVEL PAYMENTS AT AN INTEREST RATE OF 3.99 % RESULTING IN TEN (10) ANNUAL PAYMENTS OF \$169,168.20 WITH THE SAID ANNUAL PAYMENT AND INTEREST RATE SUBJECT TO CHANGES AS FINANCIAL MARKET FORCES WILL REQUIRE GIVEN THE TIME NECESSARY TO HOLD THIS MANDATORY REFERENDUM IN ACCORDANCE WITH THE REQUIREMENTS OF SECTION 109-B OF THE

GENERAL MUNICIPAL LAW AND FURTHER EVALUATION OF FINANCING ALTERNATIVES, AND THAT THE ANNUAL SPENDING LIMITATION OF THE FIRE DISTRICT SET UNDER SECTION 176 OF THE TOWN LAW BE RAISED BY THE AMOUNT OF SUCH ANNUAL PAYMENT FOR SUCH TEN (10) YEAR PERIOD, BE APPROVED"
