WHEREAS, the BOARD OF FIRE COMMISSIONERS of the NORTH MASSAPEQUA FIRE DISTRICT has obtained a quote for the purchase of such equipment from Spartan and Pierce manufacturers based upon piggyback bidding permitted under General Municipal Law §103 through the Houston Galveston Area Council purchasing cooperative and for the financing of an installment purchase contract from 911 Leasing.com/ Republic First National, and

WHEREAS, the down payment for the purchase of the two vehicles will remain the same but the financing will change such that first installment financing total for April 4, 2023 will be for \$1,293,982.00 and the additional installment financing will be for an additional \$523,132.00 both financed over a ten (10) year period such that the payment every six (6) months will change from \$85,762.21 to \$120,529.97 based upon a blended interest rate considering the rate for the new sum to be 5.4% subject to market fluctuation that may occur in the time it takes to complete the mandatory referendum process, same being based upon the following: One Spartan Pumper:

- (c) if the capital improvements may be financed with indebtedness, a statement indicating the estimated total cost of the capital improvements, inclusive of the cost of financing, if financed pursuant to the Local Finance Law.

- (d) a statement indicating the estimated total cost of the proposed capital improvements, inclusive of the cost of financing, if financed pursuant to an installment purchase contract.
- (e) a comparison of the estimated total costs required by subdivisions (c) and (d) of this section; and
- (f) a recommendation as to whether it is in the best interests of the political subdivision to finance the capital improvements pursuant to the Local Finance Law or pursuant to an installment purchase contract and the specific reasons for such recommendation.

IT IS HEREBY DETERMINED AND RESOLVED AS FOLLOWS:

- 1. Under Section 11.00 of the Local Finance Law, a period of probable usefulness is set for fire apparatus [20 years] and exceeds the Ten (10) years proposed for the installment purchase contract to acquire this apparatus.
- 2. The proposed project relates to the purchase of a One Spartan Pumper and One Pierce Ladder Truck Fire Apparatus from Spartan and Ferrara fire apparatus manufacturers, respectively, at a total cost of \$3,017,114.00 if the fire apparatus were to be purchased outright without any form of financing. The Board of Fire Commissioners proposed to purchase the One Spartan Pumper and One Pierce Ladder Truck Apparatus by paying the sum of \$1,200,000.00 from capital reserve funds and from financing the remaining balance of \$1,817,114.00.
- 3. The Board of Fire Commissioners employed the firm of Munistat to perform a financial analysis of the installment purchase contract entered into by the Board after the 2023 mandatory referendum to purchase a Spartan Pumper and a Ferrara Ladder Truck it in light of other financing alternatives available.
- 4. Munistat provided a report a 2023 summarizing the various financing alternatives and the cost of the project over time for each alternative.
- 5. Subsequent to entering into the contract the Board learned that Ferrara could not deliver the ladder truck and the Board was forced to substitute a Pierce ladder truck and negotiate a revised installment purchase contract to amend the contract to which it was already obligated subject to a mandatory referendum to amend such contract. In light of the fact that the Board is forced to renegotiate and amend an existing installment purchase contract, there is no adequate financing alternative.
