Spoke with him today and he is going to reach out again on Wednesday regarding scheduling. External auditors have completed their on-site work for 2024 financials. Doug Missack's last day on payroll was Friday July 4th. He is now officially retired. Annual NFPA ground ladder testing completed with no issues. Fire PPE fitting will be Monday July 21 at 7pm at Station 2. Five members coming off probation need new gear (FFs GILROY, SKOZLAS, CURRAN, KARCZ, N. RUSSO. Stair chairs and stretcher systems for both ambulances are at end of life. I would ask we replace stair chairs ASAP and budget for stretcher/powerload systems replacement next year. Hollborn is still waiting on UPS batteries and transfer switch to come in then he will come install in 660. American Door came to spec bay door motors for E665 and R664. I called over for the quote this morning and Larry (owner) was away until tomorrow. I should have accurate numbers tomorrow. Will be NYS Contract pricing and I would estimate no more than \$7500 total based upon my experience. Station 2 truck room renovations have begun and will continue throughout the next month. Station 2 floor replacement estimated at \$36K (NYS Contract from Parsons) New gear lockers for Station 2 (Gear Grid, same as HQ) will be approximately \$25K (including freight). They are going to send an official quote when the manager is back from vacation later this week. Still waiting on HVAC replacement quote from Albano for Station 2 Members Room. I am going to get additional quotes in the interim. I would estimate approximately \$15K to be on the safe side (including all labor). HQ meeting room monitor (85") is \$2000 and additional \$200 for proper mounting hardware. Total \$2200. HQ EOC room/restroom HVAC repaired (bad sensors from thermostats). Kitchenette construction to tentatively begin next week. Contractor will have a better idea of timing towards end of this week. District Office hot water heater replaced by Bryan and myself last week. Requested two additional quotes for Station 2/District parking lot resurfacing. Commissioners Schmidgall, Maroldo, and Timpano and Dep. Treas. Lang-Gross booked for AFDNYS conference in Saratoga in October.
